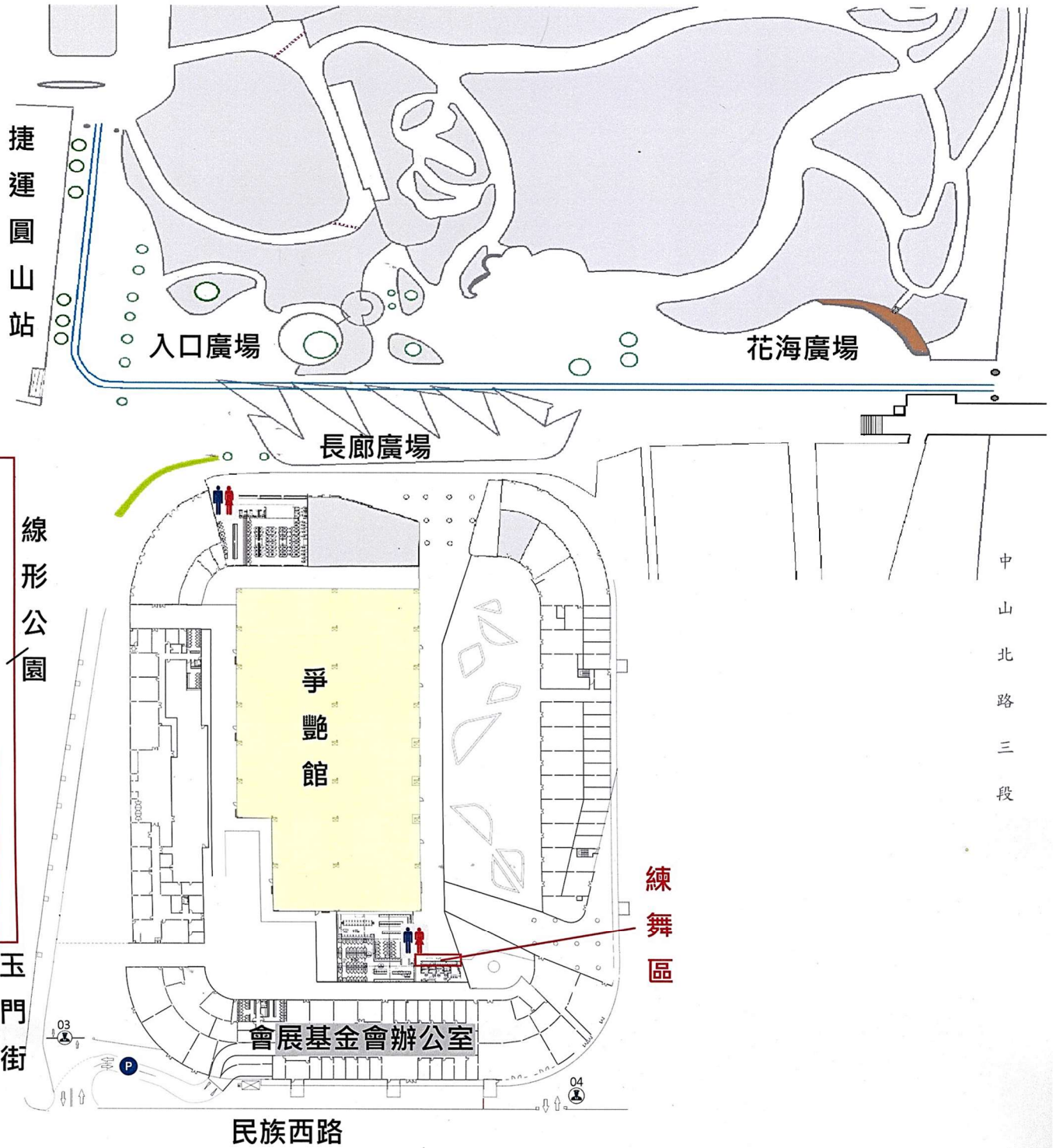


附件、花博練舞區照片、位置圖及使用須知





花博公園圓山園區爭艷廣場鏡面空間使用須知

- 一、開放時間：全天候使用，倘配合爭艷館及爭艷廣場舉辦各項特定活動，將暫停開放使用。
- 二、使用方式：採先到者優先使用，禁止以物品占用場地，妨礙他人使用
- 三、為維護本場地之安全與秩序，現場活動人員應遵守下列規定：
 - (一) 本場地僅提供一般休憩休閒活動，不得從事拋接等危及自身或他人安全之活動，並應注意自身安全及謹慎看管自有財物，如有受傷或財物失竊事件，本會不負賠償之責。
 - (二) 現場之設施、設備，活動人員不得任意更改、移動原有之配置，並應負正常使用及維護之責，若有損壞應照價賠償。
 - (三) 活動人員不得從事任何商業行為，亦不得私自張貼各種宣傳標語及海報。
 - (四) 嚴禁賭博、飲酒、吸菸、嚼食檳榔、打赤膊及其他違法或違規行為，人員應保持場地整潔，不得攜帶危險物品及任意畫線或設置標誌。
 - (五) 應遵從本會管理人員之勸導，如不依規定使用並經勸阻無效，及驅離出場。另如有造成公共危害安全者，管理單位得報請警察機關辦理。
 - (六) 使用人員若造成他人傷亡或設備損壞，應予賠償並負擔所有法律及道義責任。
- 四、本須知如有未盡事宜，得依相關規定修正之後公告。

Usage Regulations for the Taipei Expo Park mirror space

1. Opening Hours:24hours.
In case of special events, public use of mirror space will be temporarily suspended.
2. Usage of the space is on a first-come-first-served basis. Users must not block public access with personal belongings, or infringe upon the rights of others.
3. In the interest of order and safety, please observe the following rules when using the space:
 - (1) The space is for recreational use only. Throwing and catching, or other activities that may lead to injuries of others or yourself are not permitted. Users are responsible for their own safety and the safety of their belongings. The Taipei Expo Foundation is not liable for any injury or loss of property.
 - (2) Damage or vandalism of Expo Park property is prohibited. Users are responsible for the correct operation of the equipment and are liable for any damage caused.
 - (3) No commercial activities or advertisement posting is allowed without Taipei Expo Foundation authorization.
 - (4) Gambling, drinking, smoking, chewing betel nut, shirtless and other illegal activities are prohibited. Users should pay attention to keeping the environment clean and may not bring dangerous objects, draw lines or set up signs at will.

- (5) Users must obey instructions of management personnel. Failure to comply with the rules and warnings will result in eviction. In the event of damage, violators will be referred to the police.
 - (6) Users bear legal and moral responsibility for any compensation if their actions lead to any injuries or damage to the equipment.
4. What is left unmentioned in this regulation may be amended according to relevant regulations and announced again.
